

**STANDARD TERMS AND CONDITIONS OF
SALE OF PLANT MATERIAL**

APPLICATION: The terms, conditions, limitations, disclaimers and prices set out in this document apply to the purchase and sale of all PICO plant material, including, without limitation, budwood, scion wood and seeds. Some of PICO's plant material may be protected under Canadian or international plant breeders' rights, plant patent laws, trademark or other intellectual property laws. Customers wishing to purchase such plant material may be required to pay royalties and comply with provisions in this document relating to royalty bearing plant material.

ORDER PROCESS: Customer must provide a valid VISA or MasterCard credit card number to PICO before an order is processed. Customer must pay by cheque or credit card a deposit equal to 25% of the royalties payable on royalty bearing plant material. PICO may require a deposit on non-royalty bearing plant material. Deposits will be non-refundable if customer fails to take delivery of an order or fails to give PICO written notice of cancellation of an order at least 15 days before the estimated delivery date. The minimum charge per order, before taxes, is \$50.00. Labour intensive orders may be subject to an hourly rate charge of \$75.00 per hour.

PAYMENT: PICO's terms of payment are net 30 days from the date of invoice. Interest is charged on overdue accounts at the rate of 12.68% per annum calculated and compounded monthly from the due date until the date of payment. PICO reserves the right to process an overdue account and outstanding interest, if any, on customer's credit card. PICO will not provide plant material to any customer whose account is overdue. Customers not in good standing with PICO will be required to prepay all orders. Orders shipped to the US are payable in US funds. All orders including royalties, if any, are subject to GST.

CLAIMS: PICO will, at customer's option, credit or refund the cost of, or, where sufficient plant material is available, replace any plant material of unsatisfactory condition or quantity, provided that (a) customer notifies PICO in writing within seven (7) days of receipt of budwood or within six (6) months of receipt of scion wood or seeds and (b) the quality or condition is personally inspected and verified in writing by an accredited horticultural specialist, packing house fieldman or PICO representative. PICO will not consider any claim for plant material that has been processed, propagated, planted, modified, or improperly stored. PICO's maximum liability to customer is limited to the

purchase price of the plant material.

WARRANTY DISCLAIMER: PICO makes no express or implied warranties of any kind in connection with plant material sold by PICO, and specifically, PICO makes no warranty, express or implied, as to trueness to variety or type, performance, productivity, merchantability, freedom from virus, virus like agents or genetic abnormalities of any such plant material. This disclaimer also applies to plant materials that originated with PICO if they are sold or re-conveyed by customer in any way to a third party. It is customer's sole responsibility to make known to a third party purchaser the disclaimers and limitations of liability set out in this document. Customers acknowledge that all plant material is provided by PICO "as is" with all desirable characteristics and faults. Customer is solely responsible for determining the suitability of the plant material for any particular purpose, and for propagating and handling the material so that it may reach its greatest potential.

LIMITATION OF LIABILITY: Except as expressly provided herein, PICO shall not be liable for any incidental, special, punitive, consequential or other direct or indirect, damages, foreseeable or unforeseeable, suffered by customer or any third party purchaser from customer or its or their employees, servants or agents or any other person arising out of or in connection with the sale of plant material by PICO to customer.

CANCELLATIONS: PICO reserves the right to apply a cancellation charge for any orders cancelled by customer less than 15 days before the estimated delivery date.

SHIPPING: All plant material is shipped at customer's risk and expense. Customer is responsible for payment of all shipping costs, including, without limitation, packing materials, special packaging requirements, inspection fees, phytosanitary inspection certificates, customs costs, import duties and changes, brokerage fees and transportation and delivery charges (by courier, bus, etc.). Customer will reimburse PICO for any such expenses incurred by PICO to ensure efficient processing and shipment of plant material.

RECEIPT & ACCEPTANCE OF SHIPMENTS: Due to the perishable nature of plant material, customer should carefully inspect all shipments immediately upon arrival and promptly place the plant material in proper storage to maintain freshness.
